### **C-11 WORK PERMIT**

C11 lets entrepreneurs and self-employed individuals apply for a work permit that does not require LMIA.

Essentially, the C11 work permit is for two types of entrepreneurs. The first group is those entrepreneurs who want a temporary entry to Canada based on their entrepreneurial plans and careers. The second group seeks the C11 work permit in the context of the entrepreneurial or self-employed permanent residence program

Whether you are looking for a temporary stay or permanent residency with your Cll entrepreneur work permit, you need to prove to the immigration officer that:







• The work the applicant plans to do will create an economic stimulus for Canadians and permanent residents. The economic stimulus can mean different things. For instance, it entails the creation of new jobs, growth of Canadian exports, or development work in any particular

• The work the applicant plans to do will result in industry advancement in the country. The industry advancement can also be interpreted in different ways. Usually, the immigration officer considers a business bringing industry advancement if it: involves technological development, product/service innovation, and differentiation, or improving the skills of the

• The work the applicant plans to do is generally favourable to Canadian society with no harmful consequences and doesn't encroach upon the operations of Canadian businesses.






