Start-up Visa Key Requirements

The program's base is a start-up project proposal that is technology-based, viable and Scalable. It permits the founder and a maximum of 4 co-applicants to apply under the same start-up project. Team Sixxer Migrate helps identify the founders and the co-applicants who can play a significant role – as per experience, whether business or working – in the project's success.

Four main eligibility requirements under the Canada Start-Up visa program:



Have a qualifying business.



Get a letter of support from a designated organization.



Meet the language requirements.



Bring enough money to settle.







- to applicants with the capability to invest or participate in an idea or concept in Canada.
- Canada Start-up visa offers an excellent pathway for applicants not qualified under the Canada Express Entry because of Occupational, English Language or age restrictions or higher CRS ranking.
- canada Start-up Visa Program offers entrepreneurs and skilled professionals the needed pathway in sailing through the otherwise complex Canadian Immigration Process.

Have a Qualifying Business

- Each aspirant holds 10% or more of the voting rights attached to all corporation shares outstanding at that time (a maximum of 5 individuals may apply to owners).
- You receive a letter of support (LOS) from the DO. To get the letter of support, one must take the following steps:
 - i. Contact the designated organization (DO) to determine how to receive its backing.
 - ii. Persuade the organization that you have a business concept that is worth backing.
 - iii. Obtain a letter of support from the nominated group.

After the designated body accepts your idea, you will get a letter of support (LOS) from it. You will include this LOS at the time of presenting your application. LOS confirms that your business idea has support from the venture capital fund, angel investor group, or business incubator.

The body will also send a commitment certificate to Canadian Immigration Agencies like IRCC. IRCC will review your application, the letter of support, and the DO's commitment certificate to review your PR visa application. IRCC could ask you for additional business details to take a final decision on your petition.



Bring Sufficient Funds to settle down in Canada*

When submitting your application, you'll be required to provide evidence that you possess the necessary funds to support yourself and your dependents, post you land in the overseas hotspot. You are not allowed to borrow this money from any other individual. While the total funds you require depend on the actual size of your family, this gets updated every year.

Sixxer Migrate Immigration Services offer Turnkey Services during the entire Start-up Visa application process.

- The application will be processed under the supervision of an authorized immigration lawyer
- Assessment of the planned Start-Up business venture or business concept.
- Identify the founder Project that is likely to be eligible for the Visa category definition & meet the approval of a DO. Our preference is to deal with one of the IRCC-approved incubators.
- Identify co-applicants who will complete the group of five, including the founder.
- As per the background and experience, identify the role that each group member is prescribed to play in the project.
- Coordinate the incorporation of the Canadian Company under the due supervision of the Incorporation attorney and the shareholder's agreement.
- Preparation of the business plan by Canada-based accounting specialists that will be submitted with the Start-up pitch deck to one of the designated business incubators.
- Introducing the Start-Up visa group to the selected designated business incubator.

- Identification of the business incubator and submission of the project for consideration. The right to choose the designated incubator lies with Sixxer Migrate.
- Start-up Visa group members undergo the accelerator and mentorship program or otherwise the selection process with the business Incubator. Different incubators have different selection criteria and mentor programs.
- Coordination with the incubator on issuing the Letter of Support (LOS).
- After receiving a Letter of Support (LOS), file the family PR visa application with IRCC.
- Preparation and filing of the work permit application for interested start-up group members. Please note that filing a work permit application under the start-up visa program is not compulsory. One can file the PR visa application and wait for the application process to be completed. Please also note that the decision to approve the work permit application lies with the visa office and is not in the control of RCIC or Sixxer Migrate Immigration Services.
- Guiding the clients through the entire process leading to the PR visa issuance, including the responses to queries from the visa office.


Start-up visa – Sixxer Migrate Consulting fee

In consideration of the provision of the Services, the Client shall pay Sixxer Migrate a fee of CAD 100,000/- (Hundred Thousand CAD) as follows:

Initial retainer payable upon signing of this service agreement. This amount is CAD 15,000/only refundable if the client does not (CAD Fifteen Thousand only) receive the support letter from an IRCC-designated business incubator. Payable within seven working days of the presentation of the following documents -CAD 15,000/-(1) Business plan (CAD Fifteen Thousand only) (2) Company incorporation and Shareholding certificate. Payable within seven working days of the CAD 50,000/receipt of the Letter of Support (LOS) from (CAD Fifty Thousand only) the Incubator. Payable on applying for Work Permit CAD 20,000/-(Canada WP) (CAD Twenty Thousand only)

Start-up visa - Sixxer Migrate Consulting fee (Exclusions)

- i. The Canadian government fee for a Work Permit application or Permanent residence application.
- ii. Travel, boarding and lodging expenses during trips to Canada to meet any procedural requirements or staying and living in Canada on a work permit.
- iii. Miscellaneous expenses incurred by the applicant in preparing files locally within India include attending the IELTS test, preparing personal net worth statements, property valuations, etc.
- iv. Any taxes payable in Canada towards business operations of the Canadian entity
- v. The hiring cost of accountants to file the company's tax or personal tax returns in Canada.
- vi. Settlement costs in Canada, whether on a work permit or after the PR visa.
- vii. Any other expenses or costs not mentioned in (11) below.
