Canada Intra-Company Transfer

Proposal for Work Permits Intra-Company Transferees R205 (a) – Exemption Code C12

Canada (Work Permit) under the International Mobility Program permits international companies to establish in Canada and temporarily transfer qualified employees to Canada to improve management effectiveness, expand Canadian exports, and enhance competitiveness in overseas markets.

For us to represent your interests, you and/or other identified company executives will be required to continue demonstrating:

- **Employment in an executive or managerial capacity or one involving "specialized knowledge"**
- **Establish corporate operations in Canada.**
- **The Incorporation/Enterprise outside Canada will form a parent relationship with the subsidiary in Canada.**
- **Continuous employment in a similar position outside Canada for one year in the previous 3-year period from the date of application.**
- **Compliance with existing immigration requirements for temporary entry to Canada.**

In addition:

- We will need to use a corporate structure as required by provincial regulations.
- The company would be required to provide a credible business plan.
- Your proposed business operations in Canada would need to be substantially capitalized to support the business plan.
- The amount to transfer to your company account in Canada will depend on the business model planned for your Canadian branch/Subsidiary.

Once you have completed all the required undertakings, we will prepare and apply for the temporary work permit and temporary residence visas for accompanying family members.

Benefits:

- The initial work permit has a validity of 12 months.
- Family members, such as a spouse can receive renewable, open work permits and study permits for children can also be issued.
- Health coverage under universal health care.
- Begin qualifying for permanent residence after 12-months as you receive 200 points under express entry program or an applicable provincial nomination scheme.

Renewal of the work permit requires the evidence that:

- The Canadian and foreign companies still have a qualifying relationship.
- The new office has engaged in the continuous provision of goods or services for the past year.
- The new office has been staffed by local residents or citizens as close to the projections done in the business plan as possible.

Canada Intra-Company Transfer Process Flow



Assessment of potential candidates under the eligibility criteria.



Confirm of eligibility



If eligible, the candidate signs a retainer agreement and pays the professional fee according to the payment schedule



After documents received, we proceed with the company incorporation - the branch of client's business in Canada (client to select province) and shareholder agreement by the lawyer in Canada



After incorporation and initial corporate planning, we will start preparation of the business plan to be submitted with the work permit application



On receipt and finalization of the business plan, our lawyer will proceed with submission of the Job Offer to ESDC for approval



Simultaneously with point 6, our team will also start preparing and compiling forms and supporting documents for the work permit application



Work Permit may be extended, if certain conditions are met



Spouse and children qualify for temporary work/study permits; all covered by provincial health care (After waiting period)

Our Professional Fees

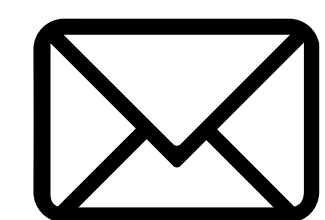

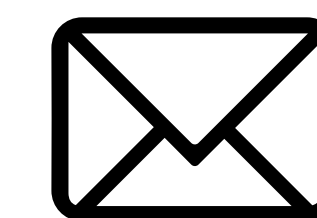
